NCG Annual Meeting 7-8 Nov 2024

This year the NCG hosted in-person annual meeting at Tata Memorial Hospital on November 7th-8th, 2024. The meeting was attended by the directors or their delegates from 200+ centres, patient groups and research organizations. The past year's progress was presented as an annual report by the team. The meeting had a diverse agenda including potential and ongoing international collaboration with ASCO, EORTC, NCI and ASEAN. The meeting highlighted the strong focus on patient and public-centric nature of all the planned NCG activities, health promotion and integrating digital technology across the spectrum of cancer care. A total of six breakout sessions with experts focused on palliative care integration, digital health including AI and machine learning, pooled procurement, health promotion, training and education initiatives, mental health and cancer, role of NGOs, and NCG-Global. Each group brought out important and implementable action points which will be taken forward by the respective groups in the coming years.









Pooled procurement of cancer medicines:

• Based on the success of first cycle of pooled procurement in improving the access and affordability of high-quality anticancer and supportive care medicines across NCG centres, the second cycle was initiated in 2024. A total of 77 anticancer medicines with 186 stock keeping units were included in this cycle. After completion of the due processes and evaluation, the rate contract has been signed by the member centres and the vendors.

CANREHAB

- CANREHAB is a multidisciplinary International conference on Cancer Rehabilitation, envisaged, pioneered and hosted by a team of rehabilitation professionals at the Tata Memorial Hospital with the vision and aim to enhance multidisciplinary interaction and collaboration among various stakeholders of cancer rehabilitation. Following the success of CANREHAB 2017 and CANREHAB 2019, The CANREHAB 2024 was held from 19 to 21 April 2024 and was supported by National Cancer Grid. The theme of CANREHAB 2024 was, "Competency, Capability and Capacity in Cancer Rehabilitation A Need in Cancer". The conference registered about 230 delegates across the country. There were eight preconference workshops conducted by eight International speakers and two days of packed symposiums, keynote talks, panel discussion, platform and poster presentation and CANREHAB Oration delivered by Professor Richard Harding.
- The hallmark of CANREHAB 2024 was the NCG lifetime achievement awards bestowed on Late Dr Aruna Tole, (Occupational therapist) and Mrs Anjali Patwardhan, (enterostomal therapist) for their exemplary work in the field of cancer rehabilitation. The conference also saw the release of the book, 'ENABLE' penned by Dr Aruna Tole and her daughter Dr Shubha Tole. The event was inaugurated by Dr Pramesh, Director TMH, Convener, NCG and graced by other dignitaries.





Health Promotion and Primary Prevention

- In our ongoing commitment to enhancing public health, the National Cancer Grid (NCG) has launched an
 innovative Health Promotion and Primary Prevention initiative. This project aims to empower individuals and
 communities with the knowledge and tools needed for better health and cancer prevention. The initiative
 aims to bridge the gaps in current health promotion efforts by developing a cohesive strategy that leverages
 digital technologies, thereby linking with broader objective of primary prevention.
- This involves collating and analyzing IEC materials, developing a theoretical framework, digitalization of health information, ensuring sustainability and collaborating with stakeholders and dissemination across diverse population groups. This includes the creation of a digital platform, such as a website or app, designed to provide a more accessible and sustainable IEC resource.
- We invite members of the NCG community and beyond to contribute to this project. Whether you have expertise in content development, digital design, health education, or simply a passion for improving public health, your input is invaluable..













Digital Health Initiatives: Update

Over the past year, the NCG-KCDO team has made notable progress in advancing its digital health initiatives. The following progress reflects our commitment to transforming cancer care and strengthening the NCG network across India.

I. Oncology EMR Implementation

We continue to make significant progress on our flagship initiative of implementing oncology-specific EMRs across NCG centers. 10 hospitals across Maharashtra, Arunachal Pradesh, Gujarat, Chhattisgarh, Meghalaya, and Jammu & Kashmir have completed the first milestone of implementation. NCG-KCDO remains committed to improving the oncology EMR solutions

2. Digital Health Foundation Course

The Digital Health Foundation Course (DHFC), is a self-paced program designed to empower oncology professionals with the essential knowledge and skills for utilizing digital health applications, covering key areas such as Health Management Information Systems (HMIS), Electronic Medical Records (EMR), clinical standards, and data privacy and security. Under implementation:

I. Telehealth for Oncology

This initiative focuses on remote oncology consultations, ensuring patients receive timely expert advice and treatment, regardless of their location. Two teleconsultation pilots, aimed at improving access to cancer care, are being implemented and will result in scalable teleconsulting models with customized operating and technology solutions.

2. Synoptic Reporting Platform

• NCG-KCDO is developing a Synoptic Reporting Platform for pathology and radiology to standardize reporting for pathologists and radiologists, improving the quality of diagnostic communication. Clinical workflows are being finalized, and the tender for software development will go live by the end of December 2024.

3. Digital Health Solution Library

• The Digital Health Solution Library (DHSL) is a centralized online repository of technology solutions applicable to cancer care. It is designed to help NCG network centers discover a wide spectrum of technology solutions



- to meet their unique needs. This initiative is scheduled to go live in January 2025.
